The speaker also highlighting the role of judiciary and judges who are considered to be one of the members of interpretative community stated that the judges have to apply their mind with that lateral perceptions, then only we can expect a better society, better law, better environment, better understanding, and whatever we are trying to achieve as a goal that can be easily achieved.

Mr. Dilip. Mazumdar, Additional Advocate General, State of Assam in his speech as a Guest of Honour, explained the object of holding of the Moot Court competition as to prepare the students to face the future challenges as a lawyer primarily. He the students who participate in the Moot Court competition prepare themselves not only for advocacy but in general they develop themselves in the entire field of law which will help them. He explained in details for the students how to prepare a case with case law, facts, jurisprudential aspect to convince the court and compared the lawyer as doctors for the clients who come to the lawyer with problem. There is no resistance for a doctor who can decide on the basis of the knowledge of medical science what medicine to prescribe but it is not the case for a lawyer because what a lawyer places will be resisted by the lawyer of the other side. The lawyer has to choose the facts and laws, and to decide

what law first to place and how to place. Mr. Sidhartha Shankar Dey, Senior Advocate, Gauhati High Court also delivered his speech as a Guest of Honour highlighting the skill of advocacy.

The Team -A consisting of students of NERIM Law College of Guwahati was announced as the Winner of the competition. The Runners up award and the Best Memorial award were presented to the Team- F consisting of the students of National Law University and Judicial Academy, Assam.
